Up to 20,000 litres of lean/rich amine, containing hydrogen sulphide removed from the gas, and 20,000 litres of lean/rich glycol, containing the water extracted from the gas, will be temporarily stored on site before being loaded onto road tankers for transport to a remote regenerating plant.
