- 1. The development hereby permitted shall be begun before the expiration of three years from the date of this permission.
- The development hereby approved shall be only carried out in strict accordance with
 the detailed specifications and plans comprised in the application hereby approved or
 in accordance with any minor variation thereof that may be approved by the Local
 Planning Authority.
- 3. No work shall commence on the construction of the refreshment, office and storage building hereby approved until details of the colour and finish of the elevations of the cabin have been submitted to an approved in writing by the Local Planning Authority. The work shall accord with the details so approved and shall be maintained in that condition in perpetuity unless otherwise agreed in writing by the Local Planning Authority.
- 4. Within one month of the shipping container hereby approved being brought onto site it shall be clad in dark brown stained timber vertical boarding and dark brown or grey pitched roof, and thereafter be maintained in that condition in perpetuity unless otherwise agreed in writing by the Local Planning Authority.
- 5. If the use of the development hereby permitted ceases, the structures and rope walk ways shall be removed from the land and the land shall, so far as is practicable, be restored to its condition before development took place.

- 1. To ensure compliance with Sections 91 to 94 of the Town and Country Planning Act 1990 as amended.
- For the avoidance of doubt and to ensure the details of the development together with any subsequent insignificant variations as may be approved in writing, comply with the provisions of NYM Core Policy A and NYM Development Policy 3.
