- ZTV analysis:
 - ZTV analysis points based on approved scheme Winding Towers at 45m above finished floor level of 200.7m AOD
 - ZTV analysis points for proposed D-Wall Rigs based on tallest part of rig at 26.2m above varying finished floor levels (203.7m AOD, 203.2m AOD & 200.7m AOD depending on location of rig). The D-Wall Rigs ZTV includes 3m shaft top analysis points.
 - Existing woodlands included in the Digital Terrain Model - woodland heights within site based on survey data, woodland heights within wider study area assumed to be 10m above ground level.
 - Observers eye level 1.7m.
 - Extent of ZTV limited to 7km distance from analysis points
 - Analysis adjusted for earth curvature / refraction
