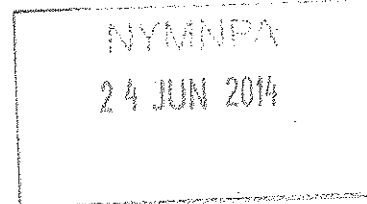

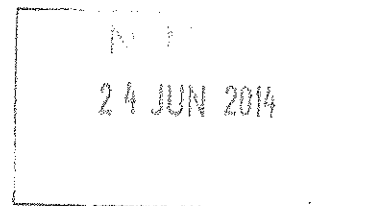
Dear Whitby Dog Rescue
