The Raw Water Pumping Station comprises of a single story brick building with associated pipes and mechanical equipment above ground located in a YWS owned compound. The compound is located between the railway line and the River and is mostly surrounded by trees. As part of Yorkshire Water Asset Management Period 5 (AMP5), this water pumping station has been identified as needing security works carrying out to bring it up to Yorkshire Water's Engineering Specification and the Standard for Protective Security Arrangements for Water Industry Operational Assets. The proposed work includes 120m of 3m high 358 mesh fencing with double leaf access gate to the main access point and two more single gates for access to Yorkshire Water owned equipment. The refurbishment work on the existing asset has been agreed by Yorkshire Water Services in conjunction with its Capital Partners, Mott MacDonald Bentley.
