There are other turbines in the area.

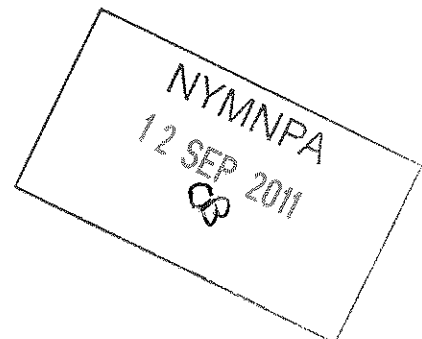
It is to be built by a small local organic dairy farming business and not by big business. Businesses like this need support.

With regards to the planning application for a wind turbine at Grange Farm, Staintondale, for Mrs JE Else and Mr MP Else.

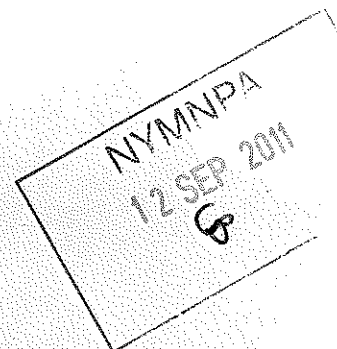
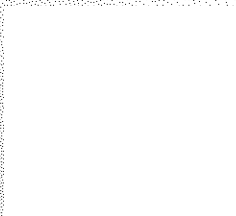

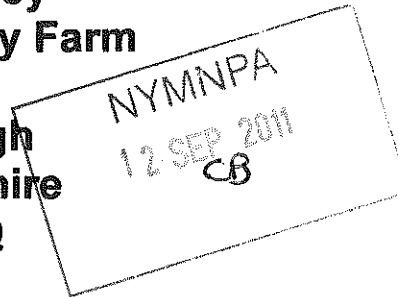
Renewable energy is very important in tackling the issue of global warming and as such I feel it is an important issue which we all should be embracing.

To whom it may concern – support for wind turbine:

I am writing this letter in support of the planning application made by Mr Else, of Grange Farm, Staintondale, North Yorkshire, to erect a wind turbine on his farm.

I am a dairy farmer, like Mr Else, within the North Yorkshire Moors National Park, and am aware that Planning Policy Statement 22 states that small-scale developments should be permitted within areas such as National Parks, AONB's and Heritage Coasts provided that there is no significant environmental detriment to the area concerned.

I believe that Mr Else's application follows these guidelines, and would point out in particular that:

- the wind turbine would be located on rolling farmland, and not open moor
- it would be placed down-slope by the farm buildings so height would not be an issue
- the installation would not be very visible
- the turbine is sized to meet the farm's electricity use only

In addition to the above points, I would like to add that I believe that the National Park should be leading the way with renewable energy installations. In this particular case, the economic benefits to the area outweigh the minimal impact the installation have on the landscape and the environment.

I have been working on a part-time basis for Mr Else for the last 16 years, and the work I do for him is a very useful part of my income. It is in my interests to see his farm continue as a viable dairy unit, and I am convinced that his application to erect a wind turbine will help him in this.

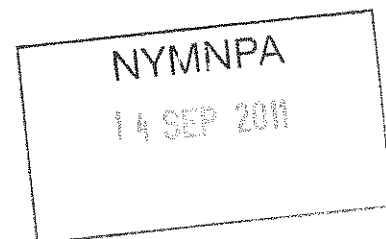
I would like to support the planning application for the following reasons

Wind Turbine Application, Grange Farm Staintondale

I was recently made aware of an application to erect a wind turbine at Grange Farm in Staintondale and wish to state my whole-hearted support for this project.

As a regular holiday maker to the area, I see no aesthetic reason to oppose this plan and in fact believe a sympathetic development may even enhance the natural beauty of the coastal moorland. I have seen several wind turbines close up and they do not spoil anyone's view or generate a noticeable amount of noise.

Much of the opposition to wind power comes from concern amongst locals regarding their property prices. However, I direct you to a study by Dent and Sims of Oxford Brookes University, the findings of which demonstrate that the effect is negligible for detached properties, which make up the vast majority of properties in the local area.

It is imperative that this country reduces its carbon emissions and land based wind power is one of the few cost effective methods of achieving this, being significantly cheaper than clean coal or nuclear power. It is up to planners and local communities to see past prejudice and support wind power for the good of the country and the planet.
