The above named Authority being the Planning Authority for the purposes of your application registered 11 November 2011, in respect of proposed development for the purposes of installation of 7 no. boardwalks (part retrospective) at Jugger Howe Moor has considered your said application and has granted permission for the proposed development subject to the following condition(s):

- 1. The permission hereby granted is valid only for five years from the date of this permission and the development shall be removed from the site before this consent expires and the site restored to its former condition before that date.
- The development hereby approved shall be only carried out in strict accordance with the detailed specifications and plans comprised in the application hereby approved or in accordance with any minor variation thereof that may be approved by the Local Planning Authority.
- 3. The timber used in the construction of the boardwalks hereby permitted shall be maintained in their natural finish or stained dark brown and thereafter so maintained unless otherwise agreed in writing with the Local Planning Authority.

#### Reason(s) for Condition(s)

- 1. To ensure compliance with Sections 91 to 94 of the Town and Country Planning Act 1990 as amended.
- 2. For the avoidance of doubt and to ensure the details of the development together with any subsequent insignificant variations as may be approved in writing, comply with the provisions of NYM Core Policy A and NYM Development Policy 3.
- 3. For the avoidance of doubt and in order to comply with the provisions of NYM Core Policy A and NYM Development Policy 3 which seek to ensure that the appearance of the development is compatible with the character of the locality and that the special qualities of the National Park are safeguarded.

#### Reason for Approval

The proposed stretches of boardwalk on Jugger Howe Moor would provide improved access and facilitate opportunities for visitors to gain a better understanding and appreciation of the special qualities of this part of the National Park.
