I write to support the planning application for the installation and erection of a wind turbine by Matthew Else of Grange Farm, Staintondale.

Dairy farms are large users of electricity, not only for the milking machines but for water heating (required for plant sterilisation), for refrigeration (to cool the milk to 4 degrees max.) and ,increasingly, slurry handling and treatment. Electricity costs are thus a large budget item and many dairy farmers are installing wind turbines in the knowledge that they are future-proofing their businesses from rising energy costs. Farmers who cannot install turbines risk becoming uncompetitive with farmers who are able to install turbines.
