Proposed replacement of St Hedda's R.C. School Canteen

Planning Application No's NYM/2012/0660/FL + NYM/2012/0665/CD

Please find below our comments re the above planning applications:-

- a) NYM/2012/0660/FL
- We do not object to the replacement of the canteen as it benefits the children. Our concern is that the proposed building appears to be double the floor space, is two storeys high and is in extremely close proximity to our property (approx 1 metre away from the boundary).
- 2. What are these meeting rooms for? Who will use them and when? Are they really necessary for a school of this type/size? What public usage will there be, if any? There is an obvious issue re privacy and security. A pathway will be created alongside a low wall, providing easy access onto our property.

Should 'Meeting Rooms' constitute the subject of a separate 'Change of Use' application, especially in a conservation village? (We ask these questions as the former presbytery yard/garden alongside our own garden became a school playground without any consultation with ourselves, similar with changes to the presbytery itself).

3. A major concern to us is the proposal to site the school kitchen within a metre of our property. The kitchen is currently at the opposite end of the building where it causes us no concern. A kitchen presents a number of problems, bearing in mind there will be an extraction fan issuing steam and cooking smells, risk of fire (what about emergency service access?) bins for waste food just over our wall (there are already rats in the area – I have pics of these), kitchen staff will look out directly into our garden thus invading our privacy + drains etc etc. We think it is most unfair that this re-location of the kitchen is even being considered.

We feel that the kitchen should either remain in its current location or be moved to the area marked 'Storage' on the enclosed plan. If anything is to be built adjacent to the boundary wall it should be the storage facility (which would not have windows) and would replace the shed which was dismantled. But preferably, because of the height of the proposed building and to show due consideration to the occupants of the adjacent cottages (built in 1865) there should be a screen of trees in this location.

- 4. The overhead power lines supplying the current canteen are routed over our property. There have been at least four incidences when the lines have been severed and power lost in the last few years. We are given to understand that an up-grade to the canteen supply is being planned and suggest that it makes sense to re-route the lines/remove the pole from our garden to the school/church complex where maintenance and repairs can be carried out without damage/NEDL access to our garden and make it far safer for the children who currently walk and play below these dangerous lines. This adaptation would also facilitate the screening of the canteen with a short line of trees, if in the future, we (or future owners), feel it is necessary to do so. At the moment we are prohibited from protecting our privacy because of the OHP lines. Surely if it is perceived that there is sufficient room for a kitchen there is room for the electric supply pole?
- 5. Should not any construction in a conservation village be in keeping with the rest of the village i.e. in natural stone? If this is to be waived because this is a replacement, surely it should be just that – a replacement one storey building of similar size?
 - b) NYM/20120665/CD Re demolition of the existing canteen. Could we please have some assurance that the asbestos roof will be removed in a controlled manner in accordance with regulations, so that there will be no escape of asbestos dust/debris onto our property

I apologise for not being succinct, but unfortunately we have not been afforded the opportunity to address these matters *prior* to the applications being submitted. We were given a copy of a plan on September 24th but we were not informed that a Planning Application had already been submitted to yourselves (received by you September 21st).

A copy of the plan given to us is attached. As you can see, this does not correspond with the plans displayed on your web-site. You will note that it excludes the second floor and other details.

We would therefore ask that you give our comments serious consideration as it appears that this is our only opportunity to air them.

I would like to add that 1, Station Cottages has been in our family for 47 years and it has been our intention to make this our retirement home. We wish to continue our good relations with both the church and the school, but genuinely feel that the proposals are inappropriate to the site.






