I have just checked online that my comments have been received and have noted with alarm the comments of Mr & Mrs Mack. Their comments are distorted, misleading and in some cases untrue.

While I was on holiday in Robin Hoods bay I noted the huge amount of work that was being done to restore this beautiful house. I saw the workmen use the ladders to gain access to the roof from the area where the bins are stored. I also observed them take the ladders away each time they'd finished their work on the roof and store them under the balcony of the garden area each night. I actually commented to them on one occasion that it looked hard work and a struggle taking the ladders over the wall and into the garden down steep steps. The workmen replied that if they left them anywhere else they'd likely to walk in the night. To suggest this area is being used as a ladder store is therefore manifestly untrue.

The plans I have viewed online of the proposed new gates clearly DO obscure unsightly bins from public view. They would enhance the aesthetic dramatically. I understand it the bins Mr Kemp uses are the bins supplied by the local authority therefore Mr Kemp has no choice other than to use them. The suggestion that gates would block the view and cause light issues is ridiculous and lacks any point of fact. You only need to visit the property to see that this claim is fabricated.
