RE Application NYM/2013/0435/FL – Light aircraft Airport at Southmoor Farm, Bickley, Langdale End

We would like to formally object to the granting of a consent to the above application. The noise necessarily caused by this change of use will cause a significant disturbance to residents and visitors alike and would disturb wildlife in the area. It would especially detract, during peak leisure times, from the peaceful rural nature of this locality which is the sole reason for the rural tourism and a major reason for the residential settlement from which the area significantly benefits. Having once moved away from an area close to an airstrip, we have grave reservations about the ability to limit the number and times of flights once a permission is granted.

The necessary functionality of the proposed hangar in accommodating ten aircraft would result in a commercial building significantly at odds with the nature of other local agricultural and commercial buildings.

Mrs Fountain requests an opportunity to speak at the meeting on 19th September, with authority for and on behalf of all consulted Bickley and Crosscliffe residents who have opposed this application.

I wish to object to the planning application NYM/2013/0435/FL to build an airstrip at South Moor farm.

I think would be a totally unsuitable development for the area and would be in contravention of the National Park Management Plan. This plan states that the aim for the future is that "the North York Moors will still be valued by many for its remoteness and tranquillity and the environment will still be as exceptional as it is today, continuing to justify its existence as a National Park."
