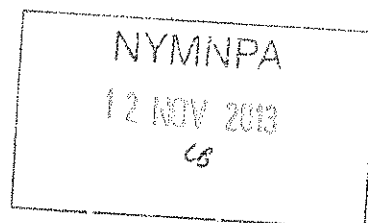

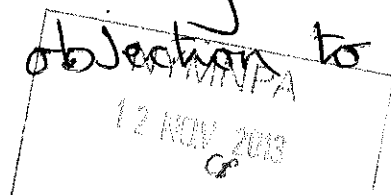

5. I payed alot of money for our Property and spent alot doing it up and I feel having this next door the Property values on Mill Lane will drop very much

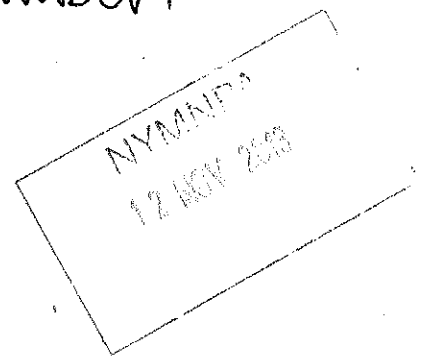
6. We have the horse riding school also and it is just all extra traffic on the road coming and going that we don't need.

Thank you for your letter dated 7th November in respect to the amended details of planning application number nym/2013/0670/fl application for construction of single storey extensions to provide bed & breakfast accommodation to 2 mill lane,hawsker.

I once again would like to object to these amended plans as I believe strongly that along with my many previous objections this type of business as no right to be sited in the residential village of hawsker where the residents enjoy the peaceful and tranquil surrounding s of the national parks area.

This type of proposal and the impact of it to the adjoining properties would only lead to the detriment of the area and more so the current privacy and amenities enjoyed by the owners of the adjacent dwellings and has been the case in so many instances of this nature it potentially only leads to future conflict due to anti-social issues, traffic issues etc. etc.

I believe it is totally unreasonable to expect people to have a business sited next to their homes which they have worked hard for and invested time and effort to improve, to have this sort of development devalue and plight a peaceful community, and also the question must be asked is there a requirement for this in the community and I believe the answer to this is a resounding no.
