The above named Authority being the Planning Authority for the purposes of your application validated 21 October 2013, in respect of proposed development for the purposes of variation of condition 4 of planning approval NYM/2011/0124/FL to extend the holiday season from eight months to 11 months (closed 11 January to 09 February in any one calendar year) at Sandfield House Farm Caravan Park, Sandsend Road, Sandsend has considered your said application and has granted permission for the proposed development subject to the following conditions:

- 1. The development hereby permitted shall be commenced before the expiration of three years from the date of this permission.
- 2. The development hereby approved shall be only carried out in strict accordance with the detailed specifications and plans comprised in the application hereby approved or in accordance with any minor variation thereof that may be approved by the Local Planning Authority.
- 3. The maximum number of caravans on the site at any one time shall not exceed 200 touring caravans
- 4. The permission hereby permitted granted relates to the use of the land for the stationing of fouring caravans. The caravans shall be used for holiday purposes only and the site shall only be occupied between 10 February and 10 January in the succeeding year (11 months).
- 5. The permission hereby permitted includes three month usage of the site during the winter months (November to January/February) when the tourist season is at its quietist and landscaping is not in full leaf, as such the site usage during these months shall be limited to areas close to the existing buildings (shower/toilet block) and make use of the existing hardstandings rather than outlying plots. A plan illustrating the areas planned for use of the site during these months shall therefore be submitted to and approved in writing by the Local Planning Authority before the winter use first commences. Once agreed these areas shall be the only ones used during this time.

Reasons for Conditions

- 1. To ensure compliance with Sections 91 to 94 of the Town and Country Planning Act 1990 as amended.
