**PARTICULARS OF PROPOSED DEVELOPMENT AND REPRESENTATIONS**

Application is being made

(a) for consent under section 37 of the Electricity Act 1989 to install or keep installed an electric line above ground.

(b) for a direction under Section 90(2) OF THE TOWN & COUNTRY PLANNING ACT 1990 that planning permission for the proposed development be deemed to be granted.

1. Particulars of proposed development. In order to provide a new electricity supply to barn conversions near High House Hawsker, Whitby it is proposed to reinforce a short section of existing low voltage overhead line strung between wood poles. This line presently supplies one customer with electricity but will on completion of the works also supply the barns. The approximate route of the existing overhead line to be upgraded is shown by means of a red line on the attached plan. The work involves replacing the open wire conductors with one bunched conductor (ABC). The line runs for approximately 50m at a voltage of 415/240 volts. An existing section of high voltage overhead line is shown as a yellow line on the plan and lengths of underground cable to be laid as green lines.

The work involves the upgrade of an existing short section of low voltage overhead line and the new properties are to be supplied via underground cables thereby minimizing the overall impact on the environment.

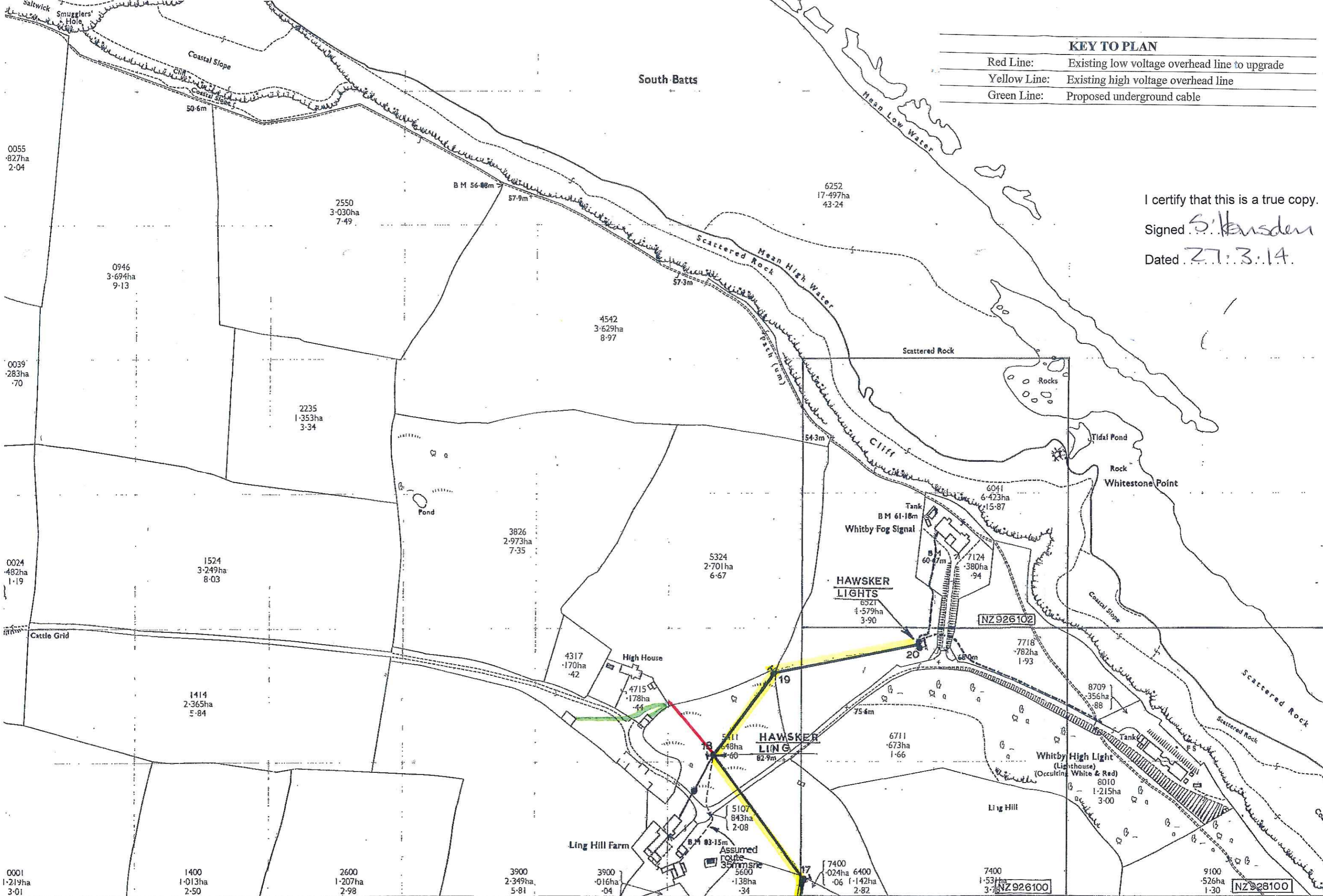
