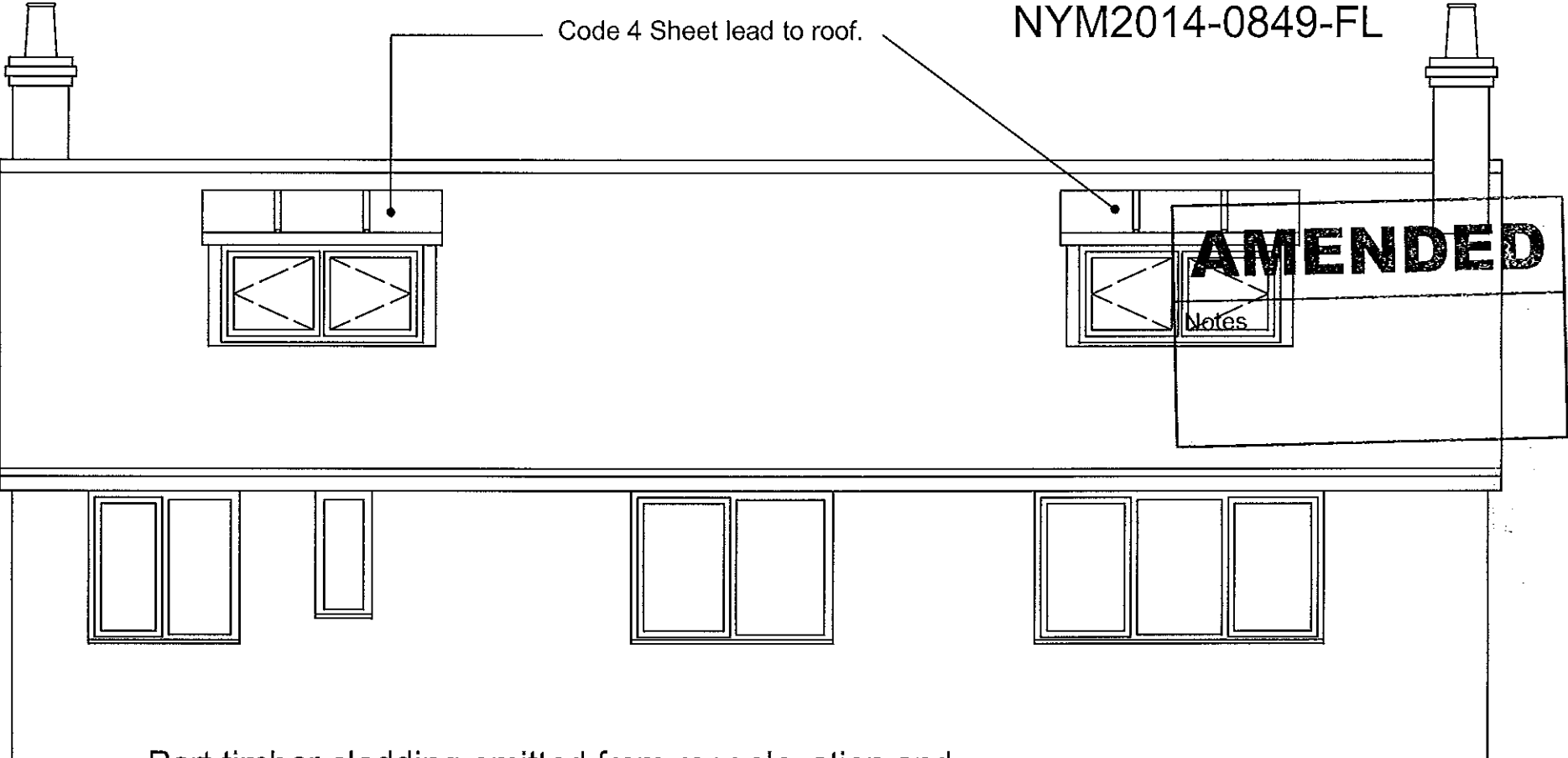
I suggest this matter can now be concluded.

PROPOSED REAR ELEVATION

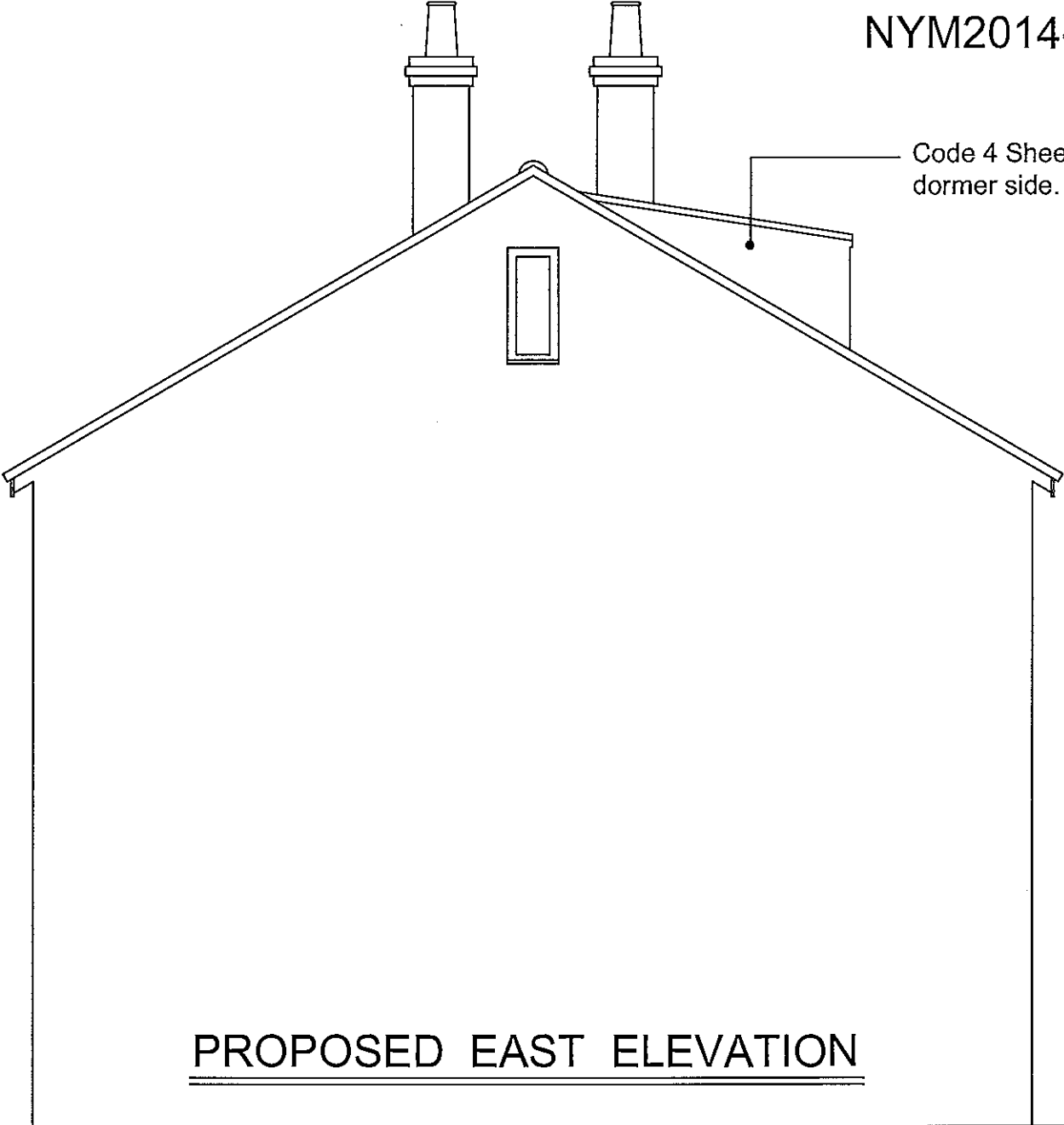

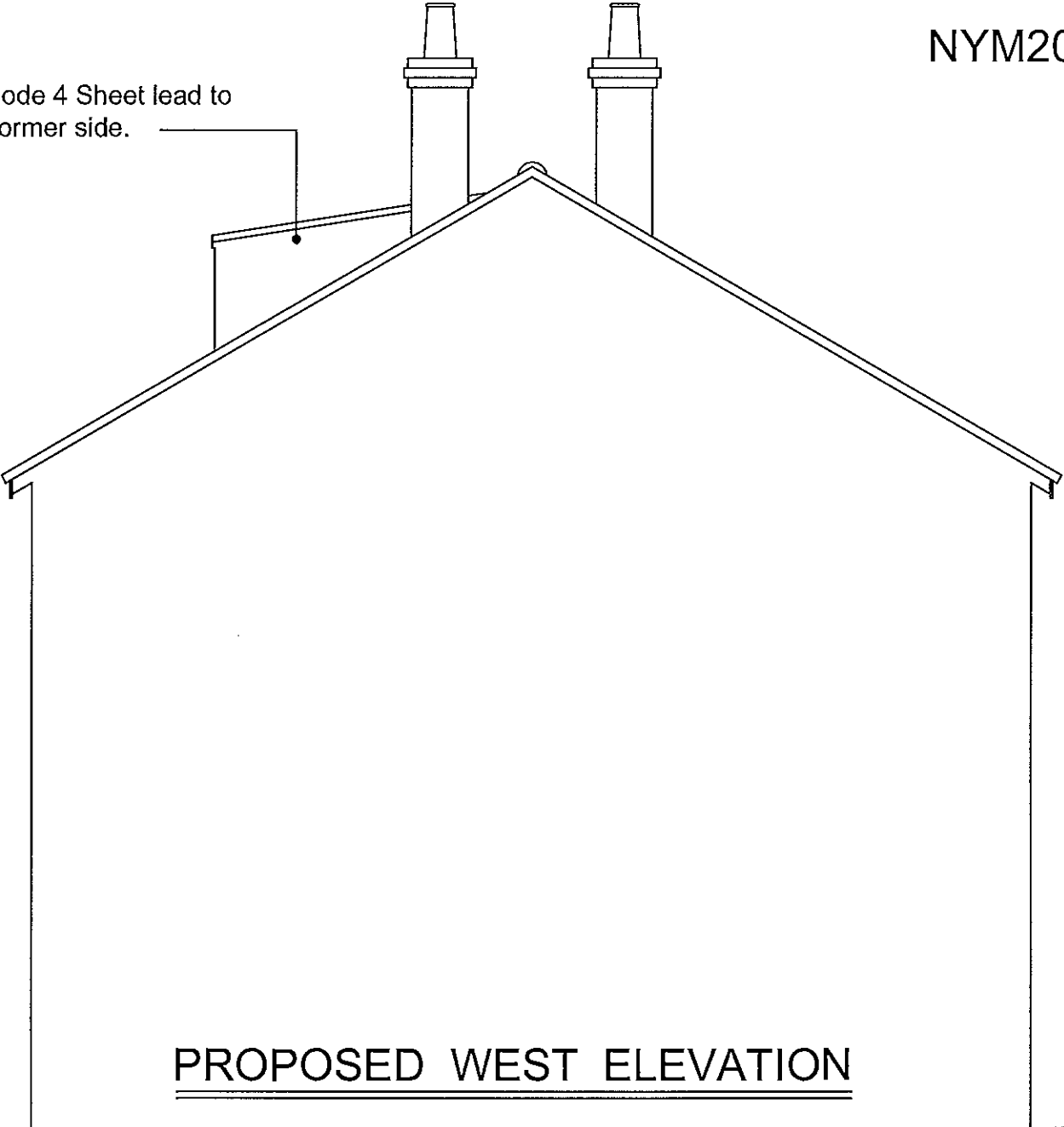


PROPOSED EAST ELEVATION

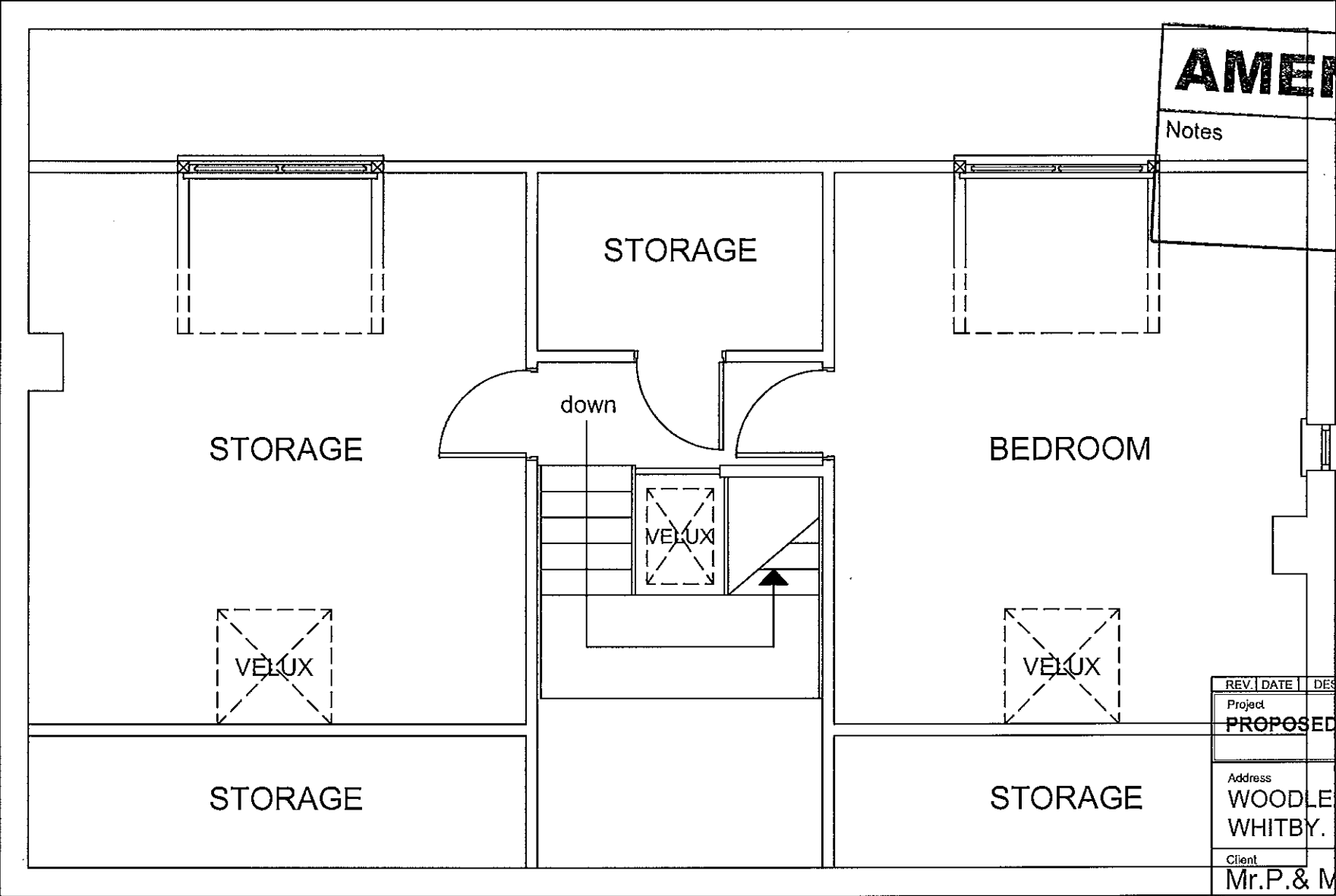
