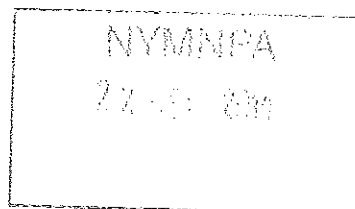

**PROPOSED AIRWAVE SUPERFAST BROADBAND INSTALLATIONS AT:  
LAND ADJACENT TO COWBANK WOOD, EGTON CLIFF, EGTON BRIDGE YO21 1UU

This is a full planning application, for permission for the development of:

**EV002b**

A 9 metre slimline column upon which will be attached one antennae, one Yagi antenna and one 500mm in diameter link transmission dishes together with an associated ground based equipment cabin measuring 1000 mm by 450mm by 1000 mm in height contained within a stockproof fence compound. The development will contain ancillary apparatus including cables all as show on the attached drawings ('the development') *at LAND AT COWBANK WOOD, EGTON CLIFF, EGTON BRIDGE, WHITBY, N. YORKSHIRE YO21 1TUU*

**EV002d**

A gable end mounted pole elevated to 15m AGL supporting one omni antenna; one panel AC link dish on the eastern elevation above the fire escape and one additional omni antenna on the south east elevation of the building at a height of approx 5m, together with an associated ground based equipment cabin measuring 1000 mm by 450mm by 1000 mm in height. The development will contain ancillary apparatus including cables all as show on the attached drawings ('the development') *at ST. MARYS FLATS, BROOM HOUSE LANE, EGTON BRIDGE, WHITBY, N. YORKSHIRE YO21 1XA*

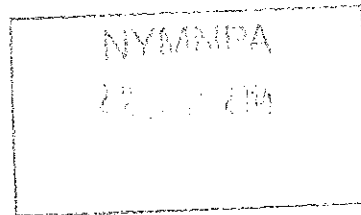
