We object most strongly to the proposed applications for the Victoria Hotel.

We have lived at our home for over 32 years and have, during that time, never suffered such nuisance as we do presently from the Victoria Hotel.

The kitchen Extractor Flue has been the subject of complaints from us for the past year. The noise from this installation intrudes into our house, being clearly audible in our lounge, dining room and kitchen. It has made our sun lounge unbearable for more than a short period of time. This is despite the double glazing. The noise outside is even worse. From breakfast time until the end of evening service in the restaurant we are subjected to the constant droning of this fan. it has severly impacted on our enjoyment of our property and makes work outside, in our garden and driveway, impossible.

The constant droning has reduced my wife to tears on more than one occasion. It is currently the subject of an investigation by SBC environmental health team.

The smell from this flue is always present when the there is little air movement. This can last for hours and completely spoils our enjoyment of the ourside of our property.

The airfow around the top of the flue is obstructed by the chimmney behind it, in fact when visible fumes (smoke) have been emitted by the flue, the airflow could be seen to be towards the ground.

I do not believe that the installation of this equipment complies with current installation guidelines and, whilst we accept that some form of air extraction is required, the present installation is badly flawed. The previous system (still visible on Google Streetview) caused no nuisance whatsoever.

A marquee was erected outside the building for all last summer. We suffered nuisance from noise, with live music being performed at high volume on a number of occasions, contavening the Hotel's strict licensing conditions reagarding noise after 22:00 hrs.

We were also subjected to a number of noisy firework displays, sometimes after midnight, as well as the disturbance from guests leaving this venue in the early hours.

In short The Victoria Hotel proprietor's determination to turn this Hotel in to a \wedding and party venue is inappropriate in what is essentially a residential area. As stated earlier, we have never ever, during our long residence here, suffered such disturbance and noise from this establishment than we have since the arrival of the present owner. He has no regard for his neighbours and constantly flouts his licensing conditions whilst ignoring all complaints from the residents of nearby properties.

We urge you to refuse these applications and help us to restore our lives to the way they were.
