Further to my email last week, I have attached the amended location plan and elevation plan to reflect the staged roof line.

All planting proposed within the landscaping scheme will be carried out to reflect the existing species mix that has been planted on the remainder of the land under the wildlife conservation scheme. The landscaping to the north east of the site involves denser planting of the old railway boundary with some Ash Trees added within the boundary line.

To the western boundary the landscaping involves planting up the existing hedgerow with new hedging to create a denser screening of the proposed development.

As discussed on site the landscaping to the south and south west involves an earth bund graduated into the landscape planted over with a Hawthorne and blackthorn field maple and Holly screening to reduce the impact of the proposed development on the landscape.
