Farm buildings on three sides of an irregular yard, reduced to two by the recent demolition of the E range to foundation level.

A cruck-built longhouse with stone mullioned windows was probably erected on the site in 1655, but has been largely rebuilt reusing the original materials. A composite barn and byre incorporating two 17<sup>th</sup>-century doors, one dated 1655, with one pair of crucks in situ, was extended to the E in 1784 by a loose box with hayloft over. A detached byre was built at right-angles to the N range 1n 1835, and later extended. After 1850 a square stone shed with a pyramidal roof was built against the barn to protect a horse-driven ground wheel, and the 1835 byre was converted to a stable.
