This is a full planning application, and notice in accordance with the electronic communications code under the Telecommunications Act 1984 Schedule 2 as amended by the Communications Act 2003, for permission for the development of:

The proposals relate to the removal of the existing 15 metre slim-line column; 3no antennas; and 1no 300mm Transmission Dish. The installation of a replacement 17.5 metre slim-line Column supporting 3no antennas; 3no 300mm Transmission Dishes; 3no. Remote Radio Units (RRU's); alteration within the existing ground based Equipment Cabin; and ancillary development required thereto.

Vodafone Limited has entered into an agreement with Telefónica UK Limited pursuant to which the two companies plan to jointly operate and manage a single network grid across the UK. These arrangements will be overseen by Cornerstone Telecommunications Infrastructure Ltd (CTIL) which is a joint venture company owned by Telefónica UK Limited and Vodafone Limited.

This agreement allows both organisations to:

- pool their basic network infrastructure, while running two, independent, nationwide networks
- maximise opportunities to consolidate the number of base stations
- significantly reduce the environmental impact of network development
