We would like the option to site static caravans painted dark green or wooden camping pods made by The Log Pod company of the same or smaller footprint than the caravans, and have these remain their natural timber colour as the timber nature of these structures is more in keeping with and less intrusive to the natural setting of the site. These units would be sited in the same positions as on the current site plan, x 2 Glamper Deluxe model in position 5 and 6; 2 x Family plus model in position 2 and 4 and 2 x Family model in position 1 and 3.

We would like to include the option to have, as well as or instead of dark green painted static caravans, timber camping pods that can be maintained in their natural timber form without the need to paint them green. The maximum number of units would remain at six.
