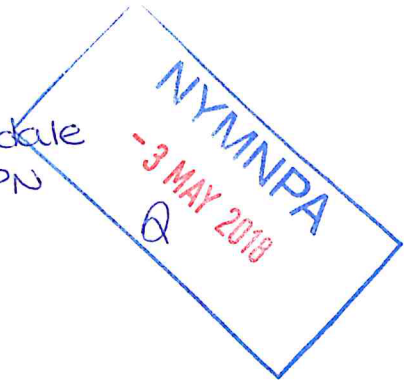
Without progress the Bay tourism will wither away- what is proposed is an appropriate and practical solution to keep tourism alive in the Bay and I hope that it is allowed.

I am writing in support of the application for the tea hut in Robin Hood's Bay. As a regular visitor for many years, I would welcome the addition of the tea hut as it would provide an additional facility for the village close to where it is needed.

A lot of seaside villages have amenities close to the beach and I think this would enhance the appeal of Robin Hood's Bay as a destination for visitors.

One of the key points to consider is will the tea hut be constructed so as to blend into landscape and enhance it rather than the opposite effect. Having looked at the details of the construction and knowing other work Graham Kemp has been involved in, I have every confidence that the tea hut will become a much loved and visually attractive feature of the Robin Hood's Bay beach front.
